

# NOTICE OF RACE PACIFIC COAST WOMEN'S DINGHY CHAMPIONSHIP April 7, 2024

**RULES:** This regatta shall be governed by rules as defined in the current *Racing Rules of Sailing (RRS)*, the ICSA Procedural Rules, and the PCCSC Standing Rules.

**ORGANIZING AUTHORITY:** The Organizing Authority (OA) is the Inter-Collegiate Sailing Association (ICSA) / Pacific Coast Collegiate Sailing Conference (PCCSC).

HOST TEAM: UC San Diego Sailing Team.

FORMAT: The Pacific Coast Open Dinghy Championship will be a 2-division rotational event sailed in CFJ's.

**ELIGIBILITY:** All PCCSC Regular or Provisional Member Schools. A maximum of one (1) women's team. As per the PCCSC Standing Rules, all competitors are required to wear their school pinnies. Sailors must meet all ICSA eligibility requirements and may be required to verify enrollment at the school they are representing.

**ENTRY:** Eligible teams must notify the host school and the Conference Commissioner by signing up on the PCCSC Live Schedule. The PCCSC Live Schedule is available at:

**FEES:** There is \$150 per team entry fee payable to 'PCCSC'. Teams must pay the entry fee for the event prior to the start of the event to be scored. The entry fee includes boats and sails which are provided. Entry fee may be paid at: <u>https://collegesailing.org/machform/view.php?id=57761</u>

**QUALIFICATION:** This event shall serve as the PCCSC Qualifier for the Women's Fleet Race National Championship.

**VENUE:** The sailing venue will be Mission Bay near the Mission Bay Yacht Club youth docks. Rotations will take place on the MBYC junior dock.

**DOCUMENTATION:** Record of Participation (RP) forms must be completed online at ts.collegesailing.org by midnight on Sunday.

**PROTESTS & APPEALS:** In accordance with rule 70.5(a), decisions of the protest committee are final. US SAILING's permission has been granted. If the requirements are not met, the decisions of the protest committee may be appealed.

**SAFETY:** A U.S. Coast Guard approved PFDs (Type III, minimum) shall be worn at all times on the water.

# HOUSING:

Limited housing may be available through the UCSD Sailing Team students. Please email Sean Lipps (<u>slipps@ucsd.edu</u>) for further information. Teams are encouraged to pursue housing with friends and family or hotels in the area first.

#### FACILITIES:

- The MBYC clubhouse is reserved for MBYC members, so please avoid using it.
