# Washington College Open Team Race Washington College – March 16-17, 2014 SAILING INSTRUCTIONS

#### 1. Jurisdiction

Races will be sailed under the management of the Regatta Chairman and the Race Committee with the advice of the Protest Committee (if applicable).

## 2. Rules

The regatta will be governed by *The Racing Rules of Sailing 2021-2024* (RRS) including appendix D, the ICSA Procedural Rules and Appendix D rules, which modify the RRS for Team Racing. When Rule 20 applies, arm signals are not required.

## 3. Notices

Notices to competitors will be posted on a board near the Washington College Sailing Locker Rooms at the Hodson Boathouse. It is the responsibility of each crew to check this notice area for information. Posted instructions may be superseded by verbal instructions from the Race Committee.

# 4. Boats and Equipment

Boats shall be sailed as supplied. Standing rigging shall not be adjusted. Equipment problems should be reported to a race committee official as soon as possible. Breakdowns must be reported to the Race Committee immediately after finishing. Breakdown requests must be in writing on protest forms located on the board.

## 5. Rotations

A schedule for boat rotation will be distributed at the Competitors Meeting and posted throughout the venue and on the official notice board. Boat rotation area and procedure will be announced at the Competitors Meeting.

#### 6. Series

The intent is to complete as many round robins as possible and to end on an odd number of round robins completed. If an even number of round robins is completed, a sail off round will occur.

# 7. Schedule

Report time for Saturday and Sunday is 0900. There will be a competitors meeting at 0915. Contestants should be ready to race immediately after the competitors meeting. Races will be conducted as expeditiously as possible with due consideration for unavoidable delays. The Race Committee may commence the starting sequence prior to the arrival of a boat or boats taking an inordinate amount of time arriving in the starting area. No race will be started after 1500 on Sunday.

# 8. Race Area

The Race Area shall be described at the Competitors Meeting.

#### 9. Course

Courses will be the Collegiate Digital N.

#### 10. Changing the Course

After the starting signal, the Race Committee may change the position of one or more marks of the course provided no competitor is on that leg. There will be no signal for such a course change (this alters RRS 33).

# 11. Abandonment

An abandonment will be signaled by a series of short whistles (alters RRS 32.1).

#### 12. Marks

Marks will be orange balls.

#### 13. Starts and Finishes

Races shall be started in accordance with *US Sailing Prescription* Appendix U3 (3 Minute Starting Sequence). The starting line will be defined by a staff displaying a Maryland state flag on the course side of the nearby orange mark. The finish line we be between a staff displaying a Washington College Sailing Team burgee on the course side of the nearby orange mark. If a competitor is delaying the finish of a race the race committee may terminate the race and score the competitor in place.

## 14. Recalls.

Individual recalls will be signaled by the display of code flag X without an accompanying sound signal, and with the hail of the individual sail numbers.

### 15. Safety

USCG approved Type III PFD's shall be worn when afloat. Dry suits may be required at the discretion of the Race Committee. Competitors who require assistance should signal by waiving both arms overhead. Capsized yachts may be righted and sailed by its crew. If the safety of the yacht or crew is in jeopardy, or if the progress of the regatta is affected, the Race Committee may require that assistance be accepted and the yacht retired from the race. Starts will not be delayed to accommodate capsized yachts. A yacht which retires from a race shall notify the Race Committee either before leaving the course area, or, if that is not possible, immediately after arriving ashore. Failure to do so may result in disqualification from that day's races. This changes RRS 64.1.

#### 16. Protests

Expedited hearing procedure, PR Appendix G shall be in effect. Protests shall be lodged and filed as per the Procedural Rules. A written protest must be submitted to a regatta official from Washington College, at the first reasonable opportunity, no later than 20 minutes, after the signal boat has docked. A boat intending to protest must be indicated by hailing the word "protest" and the sail number of the protestee immediately following the incident. A protesting boat shall, at the first reasonable opportunity after finishing, notify both the Race Committee and the protested boat of intent to protest. Failure to do so may be grounds for dismissing the protest under RRS 63.5.

#### 17. Alternative Penalties

Appendix D2 shall apply for penalties.
