SAILING INSTRUCTIONS

1. RULES

This regatta will be governed by the Racing Rules of Sailing, the US SAILING prescriptions, the Intercollegiate Sailing Association Official Rules for Intercollegiate Sailing Competition, Collegiate Dinghy Class Rules (CR), NEISA Regulations (except as any of these are altered by the Sailing Instructions) and by these Sailing Instructions.

2. NOTICES TO COMPETITIORS

Notices to competitors will be posted on the regatta white board near the entrance of the bay.

3. BOATS

- 3.1 420 boats will be provided to all competitors.
- 3.2 All standing rigging will be preset before the Regatta to make the boats as evenly matched as possible. Standing rigging shall not be adjusted or modified without authority of the Race Committee.
- 3.3 The tension of the top full batten may not be adjusted.
- 3.4 The penalty for not complying with 3.2 and 3.3 above will be disqualification from all races sailed in which the instruction was broken.

4. CHANGES TO THE SAILING INSTRUCTIONS

Any change to the sailing instructions will be posted before 0930 on the day it will take effect, except that any change in the schedule of races will be posted by 1730 on the day before it will take effect.

5. SCHEDULE OF RACES

Saturday 11 September 1030 – Report time

1045 Skippers' meeting11 A Division board launch

Sunday 12 September 0930 – Report time

0940 Board launch for first set

- 5.1 No WARNING SIGNAL may be made after 1400 on Sunday 12 September.
- 5.2 One round robin is planned. Three races, division A & division B, must be completed to constitute a regatta.

6. RACING AREA

The primary racing is Smith Cove. If the Race Committee decides to relocate the racing area between races, it will notify competitors by hail.

7. THE COURSE

The course will be announced prior to the start of the first race of the day. Changes to the course will be announced via Loudhailer before the start of the affected race. The course will consist *at least* of a mark that is to the windward of the starting line, and a second mark to leeward of that windward mark.

8. MARKS

The windward marks will be Hi-Vis inflatable marks. Either orange or Yellow may be used.

9. THE START

- 9.1 Races will be started using RRS Appendix S Sound-Signal Starting System (US SAILING Prescription) as changed in PR 18(b)(ii). The sound signal will be a whistle or horn. The Race Committee may fly a black flag invoking RRS 30.3 except the committee will hail sail numbers in lieu of posting sail numbers.
- **9.2** The starting and finishing line will be between a yellow flag on the committee boat and a mark at the pin end.

10. RECALLS

- 10.1 ICSA rule 18(b)(ii) shall apply. The Race committee will attempt to notify premature starters by hail. This does not relieve a competitor's obligation to start properly.
- 10.2 The "Round The Ends Rule" shall apply after a general recall in accordance with ICSA rule 18(b)(iii). Code flat "I" may or may not be displayed. This changes RRS 30.1.
- 10.3 Each boat's recall number will be her mainsail number.

11. THE FINISH

The finish line will be the same line as the starting line, namely a yellow flag on the committee boat and a mark. The finish line may also be a separate committee boat, using the windward mark as the pin end of a finish line.

12. PROTESTS

- 12.1 Protests shall be written on forms available on the changing float and delivered to a race committee member on the changing float while the other division is sailing their next set or for the last set of the day, 30 minutes after the last launch reaches the dock.
- 12.2 Protests, including the boat being protested, must be reported to the Race Committee immediately after finishing.
- 12.3 The jury will hear protests in the approximate order of receipt, beginning as soon as possible after protest have been received.

13. RRS 'Appendix P' shall be in effect with the changes below:

- Delete the word "first" in P2.1
- b) Delete P2.2 and P2.3.

c) P3 is replaced with: "If a boat has been protested under rule P1 and the Race committee signals a postponement, general recall or abandonment, the penalty is cancelled."

14. BOAT ASSIGNMENTS AND ROTATION

Boats and sails will be assigned at the skippers meeting. Rotations will be posted on the regatta white board. Additional rotation sheets will be brought to the rotation float.

15. COVID

15.1 Any attending schools that are not in compliance with the posted ICSA, or Academy COVID policies will not be allowed on campus, and will be excluded from the regatta.
