SAILING INSTRUCTIONS

1. RULES

- 1.1. This regatta will be governed by the current Racing Rules of Sailing (2013-2016), including Appendix D, and the Procedural Rules (PR) and Class Rules for Intercollegiate Sailing Competition 2013-2016, except as any of these are modified by these Sailing Instructions.
- 1.2. All races will be umpired.
- 1.3. RRS D2.2(a) is changed to "She shall hail 'Protest' and conspicuously display a raised open hand at the first reasonable opportunity for each."
- 1.4. PR 25 is changed to: RRS Appendix D shall be used for team racing regattas, deleting the red flag requirement in RRS 61.1(a). RRS D1.2(c) and D5.2 are changed by replacing the phrase "a red flag" with "a raised open hand."
- 1.5. RRS D4.2(b) will only be applied in the event that Round 1 cannot be completed prior to 1630 on Sunday. For Round 2 and Round 3, RRS D4.2b is deleted.

2. NOTICES TO COMPETITORS

2.1. Notices will be posted on the official regatta notice board located in main classroom of Jacobs Rock.

3. CHANGES IN SAILING INSTRUCTIONS

3.1. Any changes in the sailing instructions will be announ<mark>ced orally and posted befor</mark>e the first race in which they are to take effect.

4. SCHEDULE OF EVENTS

5. FORMAT

- 5.1. The format for the regatta is as follows:
 - 5.1.1. Round 1 Round robin of all twelve teams.
 - 5.1.2. Round 2 Round robin of the top eight teams after Round 1.
 - 5.1.3. Round 3 Round robin of the top six teams after Round 2.
- 5.2. Any changes to this format will be in accordance with PR 25(e).

6. BOATS & EQUIPMENT

- 6.1. 2013 Laser Performance FJs will be provided for all competitors, who shall not modify any boat or cause them to be modified in any way. Competitors have the option of rigging the mainsheet purchase either 3:1 or 4:1.
- 6.2. The standing rigging shall not be adjusted.
- 6.3. The penalty fo<mark>r infringing instruction 6.1 or 6.2 will be disqu</mark>alification from all races sailed in contravention of those instructions.
- 6.4. Competitors shall report all damage or loss of equipment, however slight, to CGA staff on shore or to the Race Committee Finish Boat on the water.

7. ROTATION

7.1. The rotation of boats will be in accordance with the online rotation, which will be available prior to the competitors' meeting.

8. MARKS

8.1. All rounding marks will be orange balls.

- 8.2. The starting mark will be a green ball. The starting line will be between a staff displaying red flag on the Race Committee Start Boat and the starting mark.
- 8.3. The finishing mark will be a yellow ball. The finishing line will be between a staff displaying a red flag on the Race Committee Finish Boat and the finishing buoy.

9. COURSE

9.1. The course will be a Digital N.

10. STARTING SYSTEM

10.1. Races will be started in accordance with PR 18(b)(i).

11. RECALLS

- 11.1. Individual recalls will be signaled in accordance with Procedural Rule 18(b)(ii).
- 11.2. A general recall will be used in accordance to PR 18(b)(iii), except that the "1 minute rule" (RRS 30.1) will not be used. This changes PR 18(b)(iii).

12. PROTESTS

- 12.1. Written protests, including requests for redress and breakdowns, shall be filed within 15 minutes of:
 - 12.1.1. The last race of the Round in which the incident occurred, OR
 - 12.1.2. A postponement on shore as determined by the Race Committee, OR
 - 12.1.3. Competitors coming ashore from last race of each day.
- 12.2. The protest time limit will be posted on the Official Notice Board.
- 12.3. Protest forms will be available in the Judges Room at Jacobs Rock.

13. BREAKDOWNS

13.1. When a boat suffers a breakdown in the racing area, she may request a score change by hailing an umpire or the race committee to that effect at the first reasonable opportunity after the breakdown, until the hail is acknowledged. If possible, she shall continue racing. This changes RRS D5.2 and PR 25.

14. SCORING

- 14.1. RRS D3 and D4 shall be used, as modified by PR 25 and these Sailing Instructions.
- 14.2. Overall scores will be determined by ranking the teams in order of cumulative wins in all rounds.
- 14.3. Breakdowns will be scored in accordance with RRS D.5 as changed by PR 20.
- 14.4. In the event of a tie that require a sail-off per PR 25(b) and PR 25(c), races in which tied teams met in an incomplete round shall be used as the sail-off.

15. SAFETY

- 15.1. Competitors who require assistance from rescue boats should so signify by waving arms overhead. A competitor who retires from a race shall notify the Race Committee as soon as possible.
- 15.2. Starts will not be delayed to accommodate capsized boats.
- 15.3. At the discretion of the Regatta Chairman, dry suits may be required. Notice will be given orally and on the Official Notice Board on the morning of each day of competition.

16. <u>COACHING</u>

16.1. PR 19 will apply.

17. PRIZES

- 17.1. The first place team will have their names engraved on the Leonard M. Fowle Trophy and will receive a keeper plaque.
- 17.2. The second and third places team will receive keeper plaques.
- 17.3. Teams ranked first through fourth will advance to the Laser Performance Team Race National Championship.
