

SAILING INSTRUCTIONS

1. <u>RULES</u>

- 1.1. This regatta will be governed by the current Racing Rules of Sailing and the Procedural Rules (PR) and Class Rules for Intercollegiate Sailing Competition, except as any of these are modified by these Sailing Instructions.
- 1.2. Any questions regarding these Sailing Instructions should be submitted in writing via email to Chief Judge Bryan McDonald (dude1@apple.com).

2. NOTICES TO COMPETITORS

2.1. Notices will be posted on the Official Notice Board located on Tech Score.

3. CHANGES IN SAILING INSTRUCTIONS

3.1. Any changes in the sailing instructions will be announced orally and posted on the Official Notice Board before the first race in which they are to take effect.

4. <u>SCHEDULE OF EVENTS</u>

- 4.1. 1000 Report Time
 - 1030 First Possible Warning Signal
 - 1400 No Starting Signal After

5. <u>FORMAT</u>

5.1. The event will be sailed in combined divisions with eight races scheduled.

6. BOATS & EQUIPMENT

- 6.1. Laser Performance FJs will be provided for all competitors, who shall not modify any boat or cause them to be modified in any way. Competitors have the option of rigging the mainsheet purchase either 3:1 or 4:1.
- 6.2. The standing rigging shall not be adjusted.
- 6.3. The penalty for infringing instruction 6.1 or 6.2 will be disqualification from all races sailed in contravention of those instructions.
- 6.4. Competitors shall report all damage or loss of equipment, however slight, to the Race Committee Finish Boat.

7. <u>ROTATION</u>

7.1. Teams will be assigned boats for the duration of the regatta.

8. <u>MARKS</u>

- 8.1. All rounding marks will be orange.
- 8.2. The starting mark will be yellow. The starting line will be between a staff displaying a flag on the Race Committee Start Boat and the starting mark.
- 8.3. The finishing mark will be yellow. The finishing line will be between a staff displaying a flag on the Race Committee Finish Boat and the finishing buoy.

9. <u>COURSE</u>

9.1. Course diagrams will be on the Official Notice Board.

10. STARTING SYSTEM

10.1. Races will be started in accordance with PR 18(b)(i).

11. <u>RECALLS</u>

11.1. Individual recalls will be signaled in accordance with Procedural Rule 18(b)(ii).

12. PROTESTS

- 12.1. Written protests, including requests for redress and breakdowns, shall be filed via email to the Chief Judge by Saturday April 24 at 2200.
- 12.2. Video, and/or photographs taken from any source shall not be presented by the competitors as evidence at protest hearings. This changes RRS 63.6.

13. <u>SAFETY</u>

- 13.1. Competitors who require assistance from rescue boats should so signify by waving arms overhead. A competitor who retires from a race shall notify the Race Committee as soon as possible.
- 13.2. Starts will not be delayed to accommodate capsized boats.

14. <u>COACHING</u>

- 14.1. PR 19 will apply.
- 14.2. Coach boats will be provided for all teams.
